when the police arrive at the scene, “they can see the defendant, the vehicle and the items in plain view.” The defendants do not contest that the objects were seen by the police prior to the search and seizure, but they assert the warning was not sufficient. We have previously found that a clear and articulable reasonable suspicion existed that the defendant was engaged in criminal activity because the officer had seen the missing property in plain view during the search of the vehicle. Effect of recombinant human neutrophil collagenase on chemically-induced pleurisy in the rat. The effect of the enzyme collagenase (MMP-8) on the induction of pleurisy in the rat was investigated. The systemic (intravenous administration) or topical (trituration of the chest wall) injection of collagenase (70 U/100 g body weight) decreased inflammation and exudative accumulation in a dose- and time-dependent manner. Collagenase was less effective following the intrapleural administration of 25 U/100 g body weight. This effect could be related to the inability of the enzyme to penetrate the pleural membrane. Enzyme doses as high as 100 U/100 g did not produce a more severe inflammation. Incubation of isolated neutrophils with exogenous collagenase produced an inhibition of the generation of elastase or lysozyme as detected by zymographic analysis of the cell lysates. This inhibition was not due to activation of zymogen. Purified collagenase effectively inhibited endotoxin-induced inflammation as detected by the plasma extravasation process. Thus, collagenase can inhibit both tissue destruction and an inflammatory response in the rat. Chris Fox, CP24.com A 10-year-old boy has died after being struck by lightning at a Toronto District School Board office building at 400 Weston Rd. The incident happened around 6:15 p.m. at an Ontario Works agency at the address, according to Toronto police.
