Schaumber on July 5, 2017, and released last week, instructs NLRB regional directors to serve requests for injunctive relief on businesses represented by the newly formed union at work on or before July 25, 2017. Schaumber's order came shortly after the Trump Administration announced plans to eliminate the Obama-era rule. "Like most agency officials, I am closely following the changes in the law and the litigation addressing them, and I think that the decision of Judge Scola to order the NLRB to issue the final rule is the correct one," he said.

"I think the Board has a duty to do its job to protect the rights of all workers to form unions and bargain collectively." In seeking a stay, the Trump Administration's Justice Department challenged the board's July 2016 final rule, arguing that the rule "directly and materially conflicts with the board's statutory mandate and infringes on the NLRB's authority to regulate by setting aside congressional restrictions on the exercise of its discretion." The NLRB's rule, which takes effect this Sunday, stops employers from withholding payment to unauthorized unions, including workers who have already paid for the required union certification card, as well as those who don't have the cards. The rule also stops employers from refusing to bargain with authorized unions and from delaying or refusing to bargain until an employer has received notification that the union has been certified as the employees' bargaining representative. In its 2017 National Labor Relations Board fact sheet, the Department of Justice expressed concern that the rule "requires an employer to engage in communications with an individual who has not been shown to possess authority to bind the union, despite the fact that the union has not yet obtained certification." It argued that such communications are "predetermined" and "indefinite and could be asserted in almost any situation, from the initial stages of a union's organizing effort to the mid-course stages of bargaining." In dissent, Administrative Law Judge Colleen A. Tisdale's July 26, 2016, opinion found that the NLRB's interpretation of "representational authority" in its rule had enough support in the law "that it is entitled to deference under the familiar standard set forth in *Chevron U.S.A. Inc. v. Natural Resources Defense Council, Inc.*, 467 U.S. 837, 842 (1984)." It also noted that the board had in fact received more than 100,000 public comments on the rule, and that unlike other employer rules, it was not required to make an "independent economic judgment." "While the petitioner had the opportunity to comment on it, the board did not address the two propositions of law set forth in the dissent," said the Justice Department. The Justice Department filed its petition for review in the Second Circuit Court of Appeals on July 26, and at the time of this release, it was unclear when the court would rule. The Obama-era rule would have

made union certification easier for workers to obtain.
