We are prepared to face the consequences if we show leniency towards Congress legislators who are accused of corruption," Kumaraswamy said, later expressing his gratitude to Misra and Attorney General K K Venugopal for trying to create a dialogue and restore peace. "We got a hope of redemption after taking responsibility for the mistakes and taking steps like appointment of commissioners for Lokayukta." He said all government nominees to Lokayukta are on the panel, headed by former Lokayukta Justice L Gade, former law minister P V Mohan Rao and former Lokayukta Justice Mahadev Prasad.
